Beth David Rules

- All participants must assure that they are free of the symptoms of COVID-19 infection now and on the day of the event (fever, cough, sore throat, runny/stuffy nose, muscle aches, headaches, fatigue, vomiting, diarrhea, loss of taste/smell). Even if you have not experienced those symptoms but someone in your household or that you have had close contact with has, please cancel your appointment.

- All participants must agree to report the development of the symptoms of COVID 19 or a positive COVID-19 test within 2 weeks after the event to the Beth David office.

- Only people living in one household for at least the prior 14 days can attend.

- Every person must bring and wear a face covering the entire time they are in the building.

- Please arrive at least 10 minutes prior to the time you have scheduled to meet with the Rabbi.

- All participants must be preregistered. No walk-ins will be permitted.

- Social distancing rules will be observed.

- No water or food will be provided.

ACKNOWLEDGMENT, RELEASE, AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to attend an event held under the auspices of Congregation Beth David (Beth David), 19700 Prospect Road, Saratoga, CA, in order to attend in-person religious services or other programming ("Services and Programming"), I, on behalf of myself, all family members, and my child/children, hereby acknowledge and agree to the following:

I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC"), State of California, and Santa Clara County guidelines, orders and directives regarding COVID-19. I have been advised and understand that attending in-person religious services or other programming exposes me to a risk of serious illness or death from COVID-19, or complications thereof. Notwithstanding the risks associated with COVID-19, I hereby willingly choose to attend and participate in the Services and Programming, and to fully assume the risk of illness or death related to COVID-19 arising from my participation in such activities.

I further understand and agree that in order to attend Beth David Services and Programming, I must follow all rules of conduct established by Beth David, including submitting to a health screening, as explained in applicable e-mails, in person onsite, and on signage posted at Beth David.

I agree to hold harmless, and hereby release, discharge, covenant not to sue, and waive all claims against Congregation Beth David, and all of its officers, trustees, employees, agents, volunteers, and assigns (the "Releasees") from any liability or claim whatsoever, related to COVID-19 which might occur as a result my participation in Beth David Services and Programming.

I acknowledge that this Acknowledgment, Release, and Hold Harmless Agreement ("Agreement") is a material inducement to the permission granted by the Releasees to be on the premises at Beth David and/or to participate in the Services and Programming sponsored by Beth David off-site. It is my express intent that this Agreement shall bind my minor children, other family members, and any assigns and representatives, including my estate. I have informed my non-minor family members of this Agreement and have received their consent and agreement to the terms hereto. This Agreement may not be amended, modified or changed except in a writing signed by the undersigned and Congregation Beth David, and there shall be no oral or implied waivers hereof.
